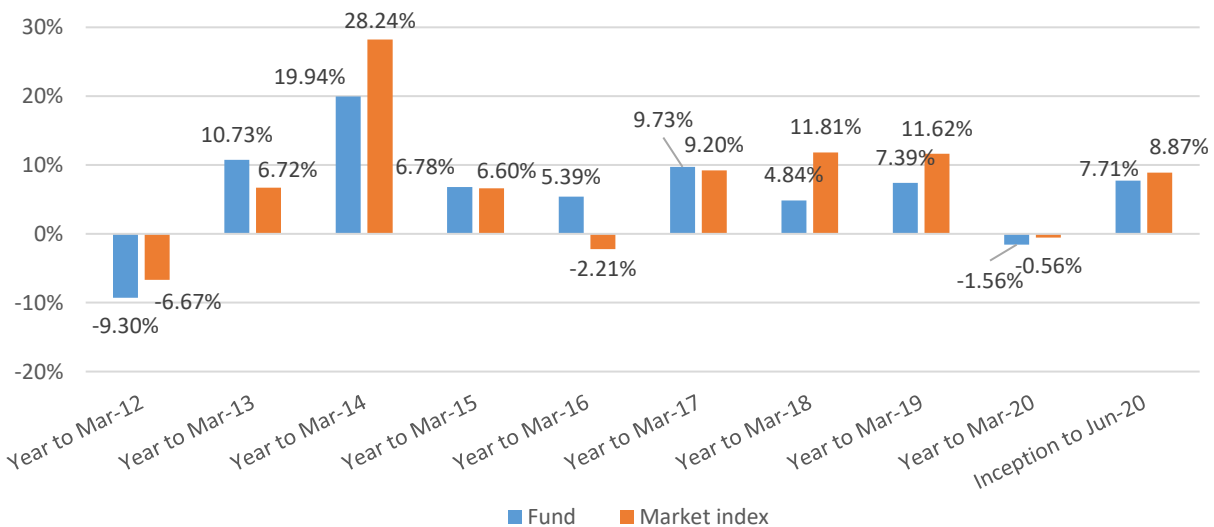

## Example of how this applies to an investor

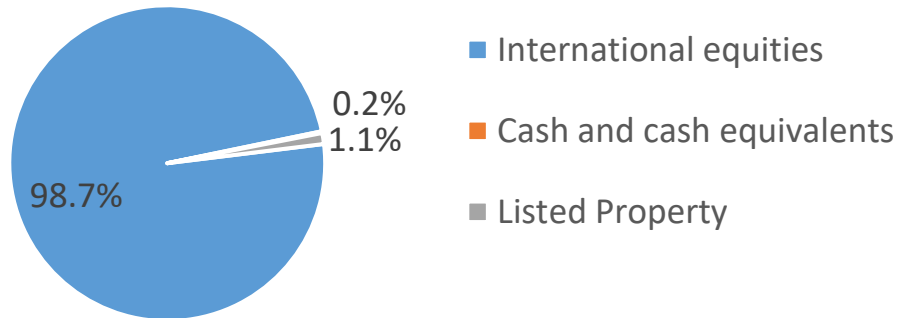
Small differences in fees and charges can have a big impact on your investment over the long term.

Angela had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Angela incurred a loss after fund charges were deducted of \$382 (that is 3.82% of her initial \$10,000). Angela did not pay any other charges. This gives Angela a total loss after tax of \$296 for the year.
